2. (a) In September, 1995, FCWC was contacted by the developer of an 8-acre parcel adjacent to but outside of FCWC's certificated service area. The developer requested that FCWC extend water service to this parcel (Barefoot Medical, Inc.) through a 2" master meter to be located within the certificated service area. FCWC thereupon consulted with PSC supervisory Staff, who indicated that pending submittal and approval of an application DOCUMENI NUMBER-DATE

for extension of service area, Staff would take no issue with FCWC's provision of service through a master meter located within the certificated service area, with FCWC simply applying its tariffed general service rate prescribed for a 2" meter.

FCWC again consulted with PSC supervisory Staff, who indicated agreement that an extension application would be appropriately filed approximately 90 days after the inception of service through the master meter located within the certificated service area.
- (c) Such water service was initiated by FCWC to the Barefoot Medical, Inc. facility in March, 1996. The facility represents one (1) Equivalent Residential Connection (ERC), and is a commercial customer.
