After reviewing the application in the above referenced docket, the staff has identified the following deficiency as well as additional information that is needed to process the application.

As required by Rule 25-30.036(3) (e), Florida Administrative Code (F.A.C.), provide a description of the territory proposed to be served, using township, range and section references as specified in Rule 25-30.030(2). Although a description was provided, it appears that the distance in the description has a slight error. Along U.S. Highway 1 (State Road No. 5) the distance appears to be 1,260 feet rather than 960 feet as stated in the territory description submitted. If this description is not correct the utility needs to rewrite the description and may need to renotice. In addition, some angles and distances were omitted. Please measure the angles and distance and include them in the revised description. Attached is a copy of the description where the missing angles and distances are identified.

A composite description of the entire Barefoot Bay Development was submitted with the application. One angle and some distances were omitted in the composite description. Please measure the angle and distances and include them in a revised composite description. Attached is a copy of the description where the missing angle and distances are identified.

To verify the composite description an attempt was made to map the utility's territory that was granted by Orders Nos. 5016 and

ORDER GRANTING CERTIFICATE

BY THE COMMISSION:

Pursuant to the provisions of Chapter 70-604, Laws of Florida, Chapter 367, Florida Statutes, the Water and Sewer Regulatory Law became effective in Brevard County, Florida, on July 2, 1970, insofar as the provisions of Chapter 367, Florida Statutes, are not inconsistent with Chapter 70-604, Laws of Florida. Subsection 367.04(1), Florida Statutes, requires that each public utility within a regulate county obtain a certificate of public convenience and necessity. Sec tion 367.06, Florida Statutes, states the information required to be submitted by the applicant public utility prior to issuance of the certificate of public convenience and necessity by this Commission. Barefoot Bay Division of GAC Utilities Inc., has applied for a certificate of public convenience and necessity under the provisions of Section 367.06, Florida Statutes, and Chapter 70-604, Laws of Florida. This Commission has examined the application of Barefoot Bay Division of GAC Utilities Inc., and found it to be in accordance with requirements set out. It is, therefore,

ORDER EXTENDING CERTIFICATE

BY THE COMMISSION:

On May 29, 1980, GAC Utilities Inc., of Florida filed an application with this Commission seeking to amend Certificate Nos. 7-W and 3-S to include territory in Brevard County, Florida.

The applicant has submitted proof of notification to all utilities registered with this Commission within ten miles of the area applied for and to the Brevard Board of County Commissioners pursuant to Section 367.061(3), Florida Statutes. Proof of publication of Notice in a newspaper of general circulation, once a week for three consecutive weeks on June 4, 11, and 18, 1980 in the area to be added was filed. There were no protests to the application and the time for filing same has expired.

The appropriate filing fee has been paid. We have considered the supportive data submitted and find it to be in compliance with applicable rules and statutues. It is, therefore,
