

WHEREAS, many residents of Calhoun County are employed in Tallahassee and are residents of Calhoun County, have personal and business contacts with Tallahassee and are in need of non-optional, two-way extended area service between Calhoun County and Tallahassee telephone exchanges.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CALHOUN COUNTY, FLORIDA as follows:

- 1. The Florida Public Service Commission and the St. Joseph Telephone and Telegraph Company of Port St. Joe, Florida and Centel Telephone Company of Tallahassee, Florida, providing service in Tallahassee and Calhoun County, are hereby officially requested to study telephone service being provided non-optional, two-way extended between Calhoun County and Tallahassee. The citizens of Calhoun County must make long distance calls to take care of their personal, medical, and business transactions, even though Tallahassee is only approximately 45 miles away.
- This is an official request of the Board of County Commissioners of Calhoun 2. County. The Public Service Commission, the St. Joseph Telephone and Telegraph Company of Port St. Joe, Florida, and Centel Telephone Company of Tallahassee, Florida, are hereby requested to study this situation immediately and make recommendations regarding such non-optional, two-way extended area telephone service.
