GTE Florida Incorporated (GTEFL) hereby gives notice of its intent to request confidential classification for certain material produced in response to Commission Staff requests during the September 30, 1996 deposition of GTEFL witness Douglas Wellemeyer. All of these exhibits elucidate on data contained in GTEFL's cost study in this proceeding. The cost study has already been filed with the Commission under confidential cover, along with a Notice of Intent to Request Confidential Classification.

The requested exhibits are: (1) work center costs by USOA account; (2) a breakdown of summary work center costs by individual work center location; and (3) the nonrecurring charge price-cost relationships supporting GTEFL witness Dennis Trimble's Exhibit DBT-3.
