Dear Ms. Bayo:

In its Order No. PSC-96-1148-FOF-TP, issued September 12, 1996, the Commission determined that Untied/Centel and MFS-FL "work together and to file with us within 30 days from the date of issuance of this order a comprehensive proposal on how 911/E911 traffic will be routed." The Order goes on to state that: "The proposal shall include a provision for backup systems, cost and price support, and a list of operational procedures for furnishing 911/E911 services." (Order, page 22.) The purpose of this letter is to provide Sprint's and MFS-FL's response to the Commission's requirement for a "comprehensive proposal."

On September 19, 1996, United Telephone Company of Florida and MFS Communications Company, Inc. entered into a Partial Interconnection Agreement for LATA 458, which resolves most interconnection issues between the companies. The remaining unresolved issues have been submitted to this Commission for arbitration in Docket No. 960838-TP. One of the resolved issues covered by the Partial Interconnection Agreement is the provision of 911/E911 service. Sprint and MFS believe that their agreement adequately addresses the 911/E911 requirements of Order No. PSC-96-1148-FOF-TP and the needs of the end user customers. The companies will be filing their Partial Interconnection Agreement with the Commission in Docket No. 960838-TP shortly.

I have been authorized by the attorneys for MFS-FL to provide this response on behalf of MFS-FL, as well as for Sprint.


