After reviewing the application in the above referenced docket, the staff has identified the following deficiencies as well as additional information that is needed to process the application.

- 1. As required by Section 367.045(1)(a), Florida Statutes (FS), and Rule 25-30.030, Florida Administrative Code (FAC.), the utility must provide notice of the application and provide affidavits that the notice was given. The notice must be published in a newspaper. The application stated that the affidavit of newspaper noticing would be a late filed exhibit. Please file the affidavit when the noticing is complete.
- ACK 2. As required by Rule 25-30.036(3)(p), Florida Administrative Code (FAC.), provide the applicant's current certificate No. 189-W for possible amendment.

Please send us a copy of the proposed territory description and a copy of the composite territory description in Word Perfect 6.1 for Windows format or similar format on a 3 % inch disc.

As we discussed, the territory granted includes a 750 foot piece of property; however, the composite territory description indicates that the distance is only 727.94 feet. It is my understanding that Mr. Chuck Bliss, Engineer for the utility, has already written an explanation of the reason for this difference and will provide a map to illustrate the difference.
