On April 26, 1996, in accordance with Section 367.022(8), Florida Statutes, Vestcor Realty Management, Inc., filed an application for a reseller exemption on behalf of Mandarin Lanai Apartments (Mandarin). Mr. John S. Ranney was appointed to serve as the applicant's agent for filing purposes. The application was deemed incomplete, however, pending correction of certain filing deficiencies.

On October 1, 1996, Mr. Ranney notified the Commission that Mandarin was withdrawing its request for a reseller exemption since it does not intend to resell water to residents at this time. Therefore, since Mandarin is no longer seeking an exemption, this docket should be closed. Mr. Ranney's letter concerning withdrawal of the application is attached.
