A parcel of land lying in said Section 11, Township 30 South, Range 38 East, Brevard County, Florida:

Begin at the Southwest corner of Said Section 11, thence East along the South line of said Section 11 for 1617.4 feet; thence N 23°53'16" W parallel with the Florida East Coast Railroad right of way a distance of 190.7 feet; thence N 77°07' 44" E, a distance of 581.4 (plus or -) feet to the Westerly boundary of U.S. Highway 1 (State Road No. 5); thence Northwesterly along said westerly boundary 1229.3 feet (plus or -); thence West a distance of 270 feet (plus or -); thence South 280 feet (plus or -); thence West a distance of 250 feet (plus or -); thence S 23°52'14" E parallel with the Florida East Coast Railroad right of way a distance of 170 feet (plus or -); thence West a distance of 115.6 feet (plus or -); thence N 23°52'14" W along the easternmost boundary of said railroad right of way a distance of 170 feet (plus or -); thence West, a distance of 1044.9 feet (plus or -), to a point being on the East boundary of Section 10, Township 30 South, Range 38 East; thence S 00°09'34" along the West line of said boundary line a distance of 1188 feet to the POINT OF BEGINNING.
