Dear Ms. Bayo:

By letters dated October 7, 1996 and October 15, 1996, the Commission Staff requested LDDS WorldCom to provide certain information regarding switched access benefits and revenue benefits.

In response to that request, the estimated switched access benefits are set out in Exhibit A and the estimated revenue benefits by product are set out in Exhibit B. Pursuant to section 364.183, Florida Statutes, and Rule 25-22.006(5), Florida Administrative Code, LDDS WorldCom hereby requests that this response be treated as proprietary and confidential. The response identifies specific cost information necessary for product lines, and this cost information, if disclosed publicly, would be of value to competitors of LDDS with respect to markets, planning, and business activities. Public disclosure of the customer list would adversely affect LDDS. This information is not publicly provided by LDDS nor is it available from other sources.
