- 4. Order PSC-96 112C FOR WO was timely protected by certain affected customers: this docket is scheduled for formal hearing according to the terms of Order PSC-96-1269-PCO-WS;
- 5. Because Petitioners and each of them are customers of the utility, any disposition of the overearnings, any adjustment in revenue requirement, and/or any adjustment in rate structure would affect their monthly recurring utility bills, to their potential detriment;
