NOTICE OF HEARING

A hearing will be held in this case at the Dade County Courthouse (report to Room 1600 for room assignment), 73 West Flagler Street, Miami, Florida, on February 6, 1997, beginning at 9:00 a.m., or as soon thereafter as can be heard. Continuances will be granted only by order of the Administrative Law Judge for good cause shown.

ISSUES: Whether Petitioner diverted electrical current and/or tampered with the meter as alleged by Respondent and, if so, the appropriate amount that should be billed.

AUTHORITY: Chapter 120.57(1), Florida Statutes, Chapters 28-5 and 60Q-2, Florida Administrative Code, and the provisions of law set forth in the pleadings.

The parties shall arrange to have all witnesses and evidence present at the time and place of hearing. Subpoenas will be issued by the Administrative Law Judge upon request of the parties. All parties have the right to present oral argument and to cross-examine opposing witnesses. All parties have the right to be represented by counsel or other qualified representative, in accordance with Rule 60Q-2.008, Florida Administrative Code.
