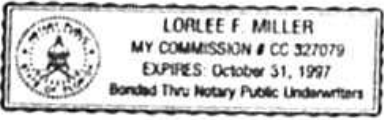

NOTICE is hereby given, pursuant to Section 367.045, Florida Statutes, of the application of Poinciana Utilities Inc. to amend its Certificate 103-S for wastewater service to add territory in Polk County, Florida as follows:

A parcel of land lying in Section 19, Township 28 South, Range 29 East, Polk County, Florida more particularly described as follows:

Starting at the Southeast corner of the Southeast 1/4 of the Southwest 1/4 of Section 19, Township 28 South, Range 29 East, as a POINT OF BEGINNING; thence North 175 feet; thence East 100 feet; thence South 175 feet; thence West 100 feet to the POINT OF BEGINNING, and all that part of the East 1/2 of Section 19, Township 28 South, Range 29 East lying North and West of the following described line: Beginning at a point 75 feet North of the Southeast corner of the Southwest 1/4 of Section 19, Township 28 South, Range 29 East, Polk County, Florida run thence East 225 feet; thence at an angle of North 50° 45' East, for a distance of 2250 feet, thence North 42° East for a distance of 675' to the waters of Lake Hatchineha. Dear Resident:

Enclosed is a copy of the legal notice, that Poinciana Utilities Inc. filed an application to extend its wastewater service territory to include the Lake Hatchineha Estates area.

Upon approval by the Florida Public Service Commission, the South Florida Water Management District (SFWMD) will start design and file for the construction permits to install the sewer system in the Lake Hatchineha Estates area. Upon Florida Department of Environmental Protection approval, we expect that construction will start May 1998 with completion by October 1998.


Upon completion of the sewer system residents may begin connection to the system. All costs of construction and connection to the system will be paid for by the South Florida Water Management District.

The proposed monthly sewer charge by Poinciana Utilities Inc. will be a base charge of \$12.68 per month and a flat monthly consumption charge of \$14.36. This is to be paid for by each customer who connects to the central system.

We will hold a community meeting sometime before construction starts to bring you up to date on construction times.
