

AT&T is a telecommunications company that has been duly certificated by the Commission as an alternative local exchange telecommunications company ("ALEC") and an interexchange company ("IXC") in Florida. As such, AT&T is subject to the rules, regulations, and orders of the Commission, and such rules, regulations, and orders impact AT&T's ability to provide local exchange telecommunications service and intrastate interexchange telecommunications service.

4. The Commission has opened this docket to address BellSouth Telecommunications, Inc.'s (BellSouth) Petition for Numbering Plan relief for the 904 Area Code.

5. AT&T's substantial interests will be affected by the action which the Commission takes in this docket regarding the proposed plans for relief because any alteration in the dialing patterns to make calls will require that changes be made to the facilities of AT&T.


