## MOTION FOR CONTINUANCE OF HEARING

GOLDEN OCALA UTILITIES, INC. ("Applicant"), by and through its undersigned counsel, files this metion pursuant to Florida Administration Code, Section 25-22.041 to continue the May 16, 1997 hearing on its Application for Original Cortificate for a Proposed or Existing System Requesting Saltist Rates and Charges with Exhibits A through K ("Application"). In support thereof the Applicant status as follows:

- 1. After the Application was filed, Utilities, Inc. of Florida ("Utitities, Inc.") filed a formal objection to the Application. After seceipt of notice of the objection by Utilities, Inc., the Applicant entered into negotiations with Utilities, Inc. for the provision of all required water and westerwater carvice to the Applicant's proposed service territory.
- 2. After receipt of notice of the objection by Utilities, Inc. Applicant also entered into negotiations with Marion County, Florida (the "County"). The Applicant and the County have now reached a tentative, verbal agreement whereby Marion County will provide all required water and westewater service to the Applicant's proposed service territory, and are in the process of reducing all of the exact terms and conditions of that agreement to writing in a formal agreement.
- 3. At this time it would be a waste of the resources and time of the Public Service Commission and of the parties to continue to process the Application, incomuch as if a formal agreement is executed between the County and the Applicant, the Applicant will have no need for a certificate to operate a water and wastewater utility in Marion County, Florida, and will voluntarily withdraw its Application.
- 4. At the same time, it would not be prudent for the Applicant to withdraw its Application at this time, inasmuch as if the County and the Applicant are unable to finalize and execute a formal written agreement, it will be necessary for the Applicant to obtain a certificate to operate a water and wasterwater utility to provide water and wastewater to its proposed service territory, and if the Application had been withdrawn, the Applicant would be required to refile an application for original certificate requiring the payment of additional filing fees, attorneys fees, and costs associated with preparation, filing and publication of notice of same.

WHEREFORE, Applicant sequests that:

- 1. The May 16, 1997 hearing be continued until such time as the Applicant requests that a hearing on the Application be reacheduled.
- 2. That all precendings, discovery and other required actions and procedures be suspended and reacheduled at such time as a hearing on the Application is reacheduled.
