The Police Department has requested that we submit these requests for a waiver of the rule because of the use of the pay telephones at these locations for allegedly illegal activities. They believe these waivers will restrict the usefulness of the pay telephones for these individuals. The Commission has previously granted a waiver of this Rule in Order No. 23762, issued November 15, 1990, approving Southern Bell's petition for waiver of the rule for pay telephones located at three laundromats owned by Mr. Patrick Collins in Miami, Florida. The owner had requested blocking of incoming calls to restrict the usefulness of the public phone for drug dealers and prostitutes.


