This letter is in response to your January 14, 1997, correspondence regarding the approval of the customer notice regarding Allowance for Funds Prudently Invested (AFPI) charges submitted by Florida Water Services Corporation (Florida Water). While Commission Staff has informally advised Florida Water of its approval, this letter shall serve as formal confirmation that the proposed notice for AFPI has been approved. In accordance with Rule 25-30.475(2), Florida Administrative Code, non-recurring charges such as AFPI are effective for service or connections made after the effective date, provided that the customers have received notice. Please provide us with a copy of the final notice for our records.

As to the Spring Hill tariffs which were approved in Dockets Nos. 920199-WS and 930880-WS, staff erroneously removed those tariffs when the final tariffs approved by Order No. PSC-96-1320-FOF-WS, issued October 30, 1996, were inserted into SSU's tariff. Therefore, staff will correct this mistake by (1) creating a new Volume VIII in the tariff titled "Spring Hill Tariffs"; (2) creating a new title page 2nd Revised Sheet No. 10 in Section I of Volume I for water and 1st Revised Sheet No. 8.0 in Section I of Volume II for wastewater reflecting this new Volume VIII in the tariff; (3) including all rate, service availability and AFPI tariff sheets in this Volume VIII labeled "Spring Hill Tariffs" that were erroneously removed by staff; and (4) including as a footnote in this Volume VIII that Hernando County rescinded jurisdiction on April 5, 1994.
