PETITION FOR APPROVAL OF WEST FLORIDA NATURAL GAS COMPANY'S REVISED PURCHASED GAS COST RECOVERY FACTORS

West Florida Natural Gas Company ("the Company"), by and through its undersigned attorneys and pursuant to the requirements of this docket, hereby petitions the Commission for approval of the Company's revised purchased gas cost recovery factors for the period April, 1997 through March, 1998. In support hereof, the Company states:

The Company is a natural gas utility company within the jurisdiction of this

3) Pursuant to the requirements of this Docket, the Company has prefiled the purchased gas cost recovery forms supplied by the Electric & Gas Department in a manner consistent with the Department's instructions. As indicated in the prefiled forms, as of the end of March, 1996 the Company will have experienced an underrecovery of \$183,415 for the period April, 1995 through March, 1996, and an revised estimated underrecovery of \$438,185 for the period April, 1996 through March, 1997. The final total true-up for the projected period April, 1997 through March, 1998 is a revised underrecovery of \$621,000. A true-up collection factor of 2.367¢ per them has been calculated.

5) As indicated in the prefiled forms, the maximum purchased gas cost recovery factor is 53.340¢ per therm for the period April, 1997 through March, 1998. This includes projected cost of gas purchased, prior period true-up, and revenue tax factors, and are based upon projected sales.

WHEREFORE, West Florida Natural Gas Company petitions the Commission to approve the foregoing purchased gas cost recovery factor, to be applied to customer bills for the period April, 1997 through March, 1998, and to billings thereafter until another purchased gas cost recovery factor is approved by the Commission.
