We are surprised and suspicious that even though your own in-field staff recommended to the Florida Public Service Commission to leave the 904 area code for Northeast Florida your FPSC Board voted otherwise!

Your people came to our area here practically unannounced to the business community less than a week before a United States holiday, so that only a few major businesses could attend the hearing. Your department did so in spite of the fact that this is such an important issue that affects over thousands of businesses in Jacksonville who will have to bear a massive financial burden which is a hundred times the amount of the expense to taxpayers than if Tallahassee's area code were changed. We hereby request another hearing. We were one of the businesses which attended the hearing, but many more wanted to be heard.

What is most disturbing is that options 1, 2 and 3, which were the only plans discussed at the meeting were never even approved. However a new option, (Option 4), was sneaked in without our knowledge or solicitation of our opinion. Since this plan was never even discussed before our panel of business leaders and political people, please enlighten me as to how it can legally be correct for your board to vote the way they did on Option 4?
