
Pasco County Utilities is in receipt of the referenced permit application which indicates that wastewater from your proposed development will be pumped through the Mad Hatter Utilities wastewater collection system to the County's wastewater transmission and treatment plant system.

Please be advised that Pasco County Utilities cannot process your application because Mad Hatter Utilities has exceeded its capacity as detailed in our bulk wastewater agreement with Mad Hatter Utilities. Also, your property is not located within the existing Florida Public Service Commission's certificated area for Mad Hatter Utilities.

Pasco County will have central sewer service available along State Road 54 in 1997. We can provide service for your development at that time. We will refund the commitment fee paid to Pasco County in the amount of \$8,225.00.
