# THE FLORIDA INDUSTRIAL POWER USERS GROUP'S PETITION TO INTERVENE

- 2. In this docket, the Commission will investigate the outage at the Crystal River 3 nuclear generating unit. This unit has been off-line for a number of months. In the most recent fuel adjustment proceeding, the Commission tentatively permitted FPC to collect approximately \$90 million in replacement fuel costs subject to the Commission's review of the outage in this investigatory docket.
- FIPUG is an ad hoc group of industrial users of electricity. FIPUG
  members use millions of kilowatt hours of electricity per year. This expense comprises
  one of members' largest variable expenditures.
  - 4. The outage at Crystal River Unit No. 3 involves a plant which has been

rate based and for which ratepayers continue to pay even though the plant is not running. Further, FPC proposes that the cost of replacement fuel during the extended outage of the plant be borne by ratepayers. Serious questions remain unanswered regarding the cause of this extended outage and where the responsibility for replacement fuel costs belongs.

- As consumers of large amounts of electricity, FIPUG has a substantial
  interest in this investigation and in ascertaining the reasons for the extended shutdown
  and corresponding increase in the fuel adjustment factor.
- FiPUG's interests will be substantially affected by the investigation in this
  docket.

WHEREFORE, FIPUG requests that the Commission grant FIPUG's petition to intervene and accord it full party status in this docket.
