Dear Ms. Bayo:

Rule 25-24.085, Florida Administrative Code, provides that any Alternative Access Vendor certificated by the Commission prior to July 1, 1995, may become an Alternative Local Exchange Company by filing with the Division of Records and Reporting a letter advising the Commission of its intent to provide local exchange service.

ICG Telecom Group, Inc. received its AAV Certificate from the Commission on June 29, 1994.<sup>1</sup> Accordingly, pursuant to the above rule, ICG Telecom Group, Inc. hereby gives notice of its intent to provide local exchange service. ICG Telecom Group, Inc. understands that such local exchange service shall be subject to all rules applicable to Alternative Local Exchange Telecommunications Companies.

<sup>1</sup> The original Certificate was issued to ICG Access Services, Inc. On September 23, 1996, ICG Access Services notified the Commission of its decision to change its name to ICG Telecom Group, Inc. On December 11, 1996, the Commission issued Order No. PSC-96-1503-FOF-TP in which it reissued the AAV Certificate 3166 to ICG Telecom Group, Inc.


