ORDER ACKNOWLEDGING NAME CHANGE

By letter dated March 17, 1997, Sun Tel I, Inc., holder of Pay Telephone Certificate of Public Convenience and Necessity Number 5083, requested that Certificate Number 5083 be amended to reflect the new corporate name, Sun Tel North America, Inc. Upon review of the Department of State, Division of Corporations' records, it appears that Sun Tel I, Inc. has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate Number 5083 to reflect the new operating name.

This Order will serve as the amended Pay Telephone Certificate of Public Convenience and Necessity Number 5083 for Sun Tel North America, Inc. Sun Tel North America, Inc. should retain this Order as evidence of the name change.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Sun Tel I, Inc. to change the name on Certificate Number 5083 from Sun Tel I, Inc. to Sun Tel North America, Inc. is approved. It is further

ORDERED that this Order shall serve as Sun Tel North America, Inc.'s amended certificate and should be retained as evidence of the name change. It is further

ORDERED that this change will be effective ten (10) days from the issuance of this Order. It is further

ORDERED that this docket is hereby closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
