To whom it may concern,

This is my third request for cancellation of my certificate. The first was mailed on Dec. 23, 1996, the second on March 7, 1997, & the third on 04-13-97. A copy of the letter mailed on March 7<sup>th</sup> is enclosed. Therefore, I do not expect to be charged a fee for 1997 due to the cancellation not occurring in 1996, by no fault of my own.

The regulatory assessment fee for 1996 was in the March 7<sup>th</sup> envelope (second request). I was not aware of any fee owed until March 5<sup>th</sup>, when I received the delinquent notice. I promptly paid the fee when notified. Therefore, once again I should not be charged any "late fee" because I was not informed of a fee due until after the Jan. 30, 1997 deadline. The difficulties I have experienced with proper notification from the Public Service Commission was a primary reason for the selling of my payphones & "attempted" cancellation of my certificate.

I was unaware of a regulatory assessment fee covering 1996 until I received the delinquent notice on March 5<sup>th</sup> I did not receive any notices preceeding the delinquent notice. The fee is included in the envelope.

I also sold my business on Dec. 22, 1996, + mailed a copy of the letter I received with my certificate number along with a note advising to cancel my certificate number. The envelope was mailed on Dec. 23, 1996 to 2540 Skunard Oak Blvd. I spoke to Charles Burnes on March 6<sup>th</sup> + he advised that envelope was not received. A second copy is included in the envelope + I again am requesting the cancellation of my certificate number.
