Dear Mr. Feil:

As you are aware staff deferred the recommendation of the above mentioned case to address the acquisition of the Burnt Store RO Association, Inc.'s (the Association) water lines by Florida Water Services Corporation (Florida Water), formerly Southern States Utilities, Inc. Please explain how Florida Water is recording this investment on the utility's books.

In addition, please verify the accuracy of the following statements. Pursuant to Section XXVII of the Purchase Agreement, the Association will interconnect with Florida Water. Florida Water estimates this expense to be between \$10,000-\$15,000, paid by the Association. Pursuant to Section XXVI of the Purchase Agreement, each customer (about 160) will pay the meter installation fee of \$90 and the initial connection fee of \$15. In addition, please clarify whether the future 80 lots in the Association will be charged the water plant capacity fee.

Please file an original and twelve copies of the requested information no later than May 2, 1997 with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399-0850.


