("FCI"), we hereby respectfully request the Florida Public Service Commission ("Commission") to assign FCI's Certificate of Public Convenience and Necessity from FCI to Fast Connections, LP ("FCLP"). On January 27, 1997, the Commission granted FCI a Certificate of Public Convenience and Necessity to operate as an alternative local exchange telecommunications company in the State of Florida.
