SECTION 1 - TECHNICAL TERMS AND ABBREVIATIONS

Application for service

A standard TeleConex order form or contract which includes all pertinent billing, technical and other descriptive information which will enable TeleConex to provide the communication service requested.

Authorized User

A person, firm, corporation or other entity authorized by the customer to receive or send communications.

Billing record change

A change in the customer billing address.

Cancellation

A customer initiated request to discontinue a service order or terminate a contract, either in whole or in part prior to its completion.

Company

TeleConex

Customer

The person, firm, corporation or other entity which orders service and which is responsible for the payment of the charges and for compliance with TeleConex regulations. For billing purposes, a customer is considered to be an account.

Disconnection

The disconnection of a circuit, dedicated access line or connection being used for existing service.

Installation

The connection of a circuit, dedicated access line or other connection for new or additional service.
