1. Tampa Electric this day is filing the testimony and exhibits of Charles R. Black relating to the annual review of Tampa Electric's coal and coal transportation prices relative to pricing benchmarks calculated in the manner previously established by the Commission.

2. The transportation price analysis is based on information supplied by two of the four municipal electric utilities relied upon by Tampa Electric for purposes of determining the transportation benchmark price. The company is attempting to obtain the transportation benchmark data from the other two municipal electric utilities and will supply that information to the Commission as soon as possible.

3. As explained in the testimony and exhibit of Charles R. Black, the company's coal and coal transportation prices for 1996 were below the coal and coal transportation benchmarks calculated in accordance with the Commission's previously approved methodology.
