We request that the pay telephones be exempted from the provisions of Rule 25-24.515(8), F.A.C., which requires that all pay telephones must allow incoming calls to be received "with the exception of those located at penal institutions, hospitals, schools and at locations specifically exempted by the Commission."

This waiver is being requested in accordance with the requirements of Florida State Statutes 120.542(2). Granting this waiver will not impeded the continued provision of pay telephone service to the using public as intended by the underlying Statute Section 364 345


