Dear Mr. D'Haeseleer:

On behalf of Midwest Fibernet Inc. ("MFI") and its parent company, Consolidated Network Inc. ("CNI") (collectively, the "Parties"), this letter is to notify the Commission of certain developments involving the above referenced docket. An original and five (5) copies of this filing are submitted. Please date stamp the extra copy of this filing and return it to us in the self-addressed, postage-paid envelope provided.

#### Intracorporate Merger Completed

By this letter, the Parties hereby inform the Commission that the intra-corporate merger that is the subject of the Parties' notification letter dated October 19, 1995 ("Notification Letter") has been completed. CNI, pursuant to the authority granted by this Commission in Order No. PSC-95-1609-FOF-II, "is continuing to provide MFI's services with no change in the operation, control, or ultimate ownership of the company providing services to Florida customers.

### Name Change to Consolidated Communications Telecom Services Inc.

Additionally (and as indicated in the Notification Letter), CNI confirms that it has changed its corporate name to Consolidated Communications Telecom Services Inc. ("CCTS"). Although CNI has changed its corporate name, the ownership of CNI remains unaffected. The company

now operates in Florida under its new name, with no change in the rates, terms, or conditions of service set forth in MFI's tariff currently on file with the Commission. Accordingly, CCTS respectfully requests that the Commission take administrative action to change the name on the certificate of public convenience and necessity issued to MFI to reflect this fact. CNI has made the necessary filing with the Florida Secretary of State to change its name and will forward, upon receipt, a copy of its authority to transact business under the CCTS name.

### TELECOMMUNICATIONS SERVICES TARIFF

# SECTION 1 - TECHNICAL TERMS AND ABBREVIATIONS

Access Line - A telephone line provided by local exchange carriers which connects a telephone or other communications device at a customer's location to Consolidated Communications Telecom Services (T) Inc.'s Underlying Carrier's telecommunications network switching (T) center(s).

Authorization or Account Code - A numerical code of four to eleven digits, one or more of which codes are available to a customer to enable the customer to lawfully connect its communication devices for the purpose of accessing the telecommunications networks of Consolidated Communications Telecom Services Inc.'s Underlying Carrier, and which thereby are used to prevent unauthorized network access and to identify the customer and its calling volumes for billing purposes.

Company or Carrier - Consolidated Communications Telecom Services (T)
Inc. - Mattoon, IL. (T)

Customer - The person, firm, corporation, end user or other entity which orders or uses services and is responsible for payment of charges.

Holidays - New Year's Day, Fourth of July, Labor Day, Thanksgiving Day and Christmas Day.

FPSC - Florida Public Service Commission.

Service Agreement - Company's standard form for the ordering and acceptance of a customer's request for and commitment to take Company's service offerings pursuant to this tariff.

Rate Center - The Points of Presence (POPS) or first point of interconnection of local exchange facilities providing access to the long distance network of the Company's Underlying Carrier and the point from which a customer's traffic is rated and billed.

Underlying Carrier - The telecommunications carrier whose network facilities provide the technical capability and capacity necessary for the transmission and reception of customer telecommunications traffic within Florida.
