

RE: Transfer application of Meadow Wood water utility system and Certificate No. 545-W.

Dear Ms. McKeever:

Meadow Wood's application for transfer of wastewater certificate requires additional information to fulfill requirements of Rule 25-30.035, Florida Administrative Code (F.A.C.).

1) With regard to your letter of June 9, 1997, in which you requested the application fee be waived because of the circumstances of the acquisition, because the filing fee is required by statute, pursuant to Section 367.071(3), Florida Statutes, (F.S.), "An application for proposed sale, assignment, or transfer shall be accompanied by a fee as provided by Section 367.145(2), F.S." The applicant shall file an application fee in the amount of \$750.00 in transfer cases where the utility has the capacity to serve up to 500 ERCs, per Rule 25-30.020(4)(c)(1), F.A.C. According to the 1996 Annual Report the Meadow Wood system has the capacity to serve 37 ERCs.

2) Pursuant Section 865.09(3), F.S., requires that fictitious names be registered with the Division of Corporations of the Department of State. That Section states, in part, "A person may not engage in business under a fictitious name unless he first registers the name with the division [of corporations] ..." According to the Division of Corporations, the name, Meadow Wood, is not registered. Therefore, Meadow Wood must register its fictitious name with the Secretary of State immediately. Proof of such registration must be provided to this office by September 15, 1997.
