**NOTICE OF INTENT TO REQUEST
CONFIDENTIAL CLASSIFICATION**

OnePoint Communications-Georgia, LLC ("OnePoint"), by and through undersigned counsel, pursuant to Section 364.183, Florida Statutes, and Rule 25-22.0006, Florida Administrative Code, hereby files this Notice of Intent to Request Confidential Classification of the highlighted portion of Composite Exhibit "F" to OnePoint's application for authority to provide alternative local exchange service within the state of Florida (the "ALEC Application"). Composite Exhibit "F" contains a Profit & Loss Statement and Balance Sheet for OnePoint's parent company. Composite Exhibit "F" demonstrates OnePoint's financial capability to provide alternative local exchange telecommunications service in Florida, which is a requirement for certification. Composite Exhibit "F", however, contains proprietary confidential business information as that term is defined in Section 364.183(3), Florida Statutes. Thus, OnePoint is filing Composite Exhibit "F" under cover of this Notice of Intent to Request Confidential Classification.

OnePoint is filing Composite Exhibit "F" to its ALEC Application in strict accordance with the confidentiality requirements of Rule 25-22.006. Accordingly, OnePoint submits herewith: (i) a separate, sealed envelope, containing one copy of Composite Exhibit "F" with the information for which OnePoint intends to request


