THE TELEPHONE COMPANY OF CENTRAL FLORIDA'S
REQUEST FOR CONFIDENTIAL CLASSIFICATION

The Telephone Company of Central Florida (TCCF), hereby files pursuant to Rule 25-22.006, Florida Administrative Code, its Request for Confidential Classification, and states the following:

1. On July 31, 1997, BellSouth Telecommunications, Inc. (BellSouth) filed its response to the Subpoena Duces Tecum served by the Florida Public Service Commission (Commission) Staff upon BellSouth on July 25, 1997. On July 31, 1997, BellSouth also filed a Notice of Intent to Request Confidential Classification for the subject information. BellSouth informed TCCF that the information contained therein pertained to customer-specific information of TCCF. On July 31, 1997, TCCF filed a Notice of Intent to Request Confidential Classification as well.

2. Staff's Interrogatory No. 43 requests BellSouth to reveal the specific services TCCF resells of BellSouth. Moreover, the information contains the numbers of resold services in each specific area in Florida. This information directly relates to TCCF's competitive interests. Disclosure of this information would impair the competitive business of TCCF by allowing competitors to determine the all of the services offered by TCCF, as well as the specific markets and number of customers and volume where TCCF

WHEREFORE, based on the foregoing, TCCF respectfully requests that the Commission enter an order declaring that the declaring the information described above to be confidential proprietary business information, and thus not subject to public disclosure.


