Sprint Communications Company Limited Partnership ("Sprint") and Sprint Metropolitan Networks, Inc. ("SMNI"), by and through their undersigned counsel, and pursuant to Rules 25-22.006, Florida Administrative Code, file their notice of intent to request confidential classification, and in support thereof state:

I. BellSouth Subpoenaed Information

1. The Staff of the Florida Public Service Commission requested Sprint and SMNI to furnish late-filed hearing exhibits 91 and 92 containing information of SMNI's customers and facilities. Such information includes the quantities and types of elements and services that ALECs have ordered from BellSouth.

2. Sprint's and SMNI's late-filed hearing exhibits include proprietary confidential business information of SMNI which is exempt from public disclosure under Sections 119.07 and 364.183, Florida Statutes. The information is confidential because it relates to SMNI's competitive interests, the disclosure of which would impair SMNI's competitive business.




