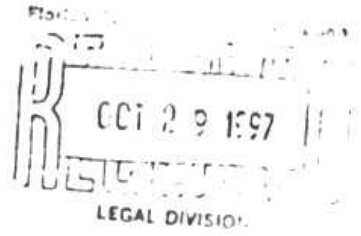

Issue 2: Should the Commission accept Mad Hatter Utility, Inc.'s offer of settlement of the show cause proceeding initiated by Order No. PSC-97-0140-FOF-WS?

Recommendation: Yes, the Commission should accept Mad Hatter Utility, Inc.'s offer of settlement of the show cause proceeding and require that the \$1,000 in settlement be paid within 10 days of the date of the order. Upon receipt by the Commission, the \$1,000 payment in settlement should be forwarded to the Office of the Comptroller for deposit in the State of Florida General Revenue Fund, pursuant to Section 367.161, Florida Statutes.

Issue 3: Should this docket be closed?

Recommendation: Upon expiration of the protest period, if a timely protest is not received from a substantially affected person, and upon verification that the utility has remitted the \$1,000 fine and has reduced its rates pursuant to its settlement offer, and upon the utility's filing of and staff's approval of the proposed customer notice and the revised tariff sheets, this docket should be closed.
