I am writing to request approval of a late payment charge for Gulf Aire Properties, Inc. D/B/A Gulf Aire Wastewater Treatment Plant. The Utility has experienced significant and continuing occurrences of late payments over the past several years. The Utility seeks approval of a \$3.00 late payment charge on each delinquent bill.

The purpose of this charge is not only to provide an incentive for customers to make timely payment, thereby reducing the number of delinquent account, but also to place the cost burden of processing such delinquent notices and accounts squarely upon those who are the cost causers. As such, our requested charge of \$3.00 is based upon consideration of both of these goals.

I am attaching hereto as Schedule No. 1 a schedule of total monthly bills sent out each month and total number of late notices, demonstrating that the Utility is currently sending late notices on an average of almost 88 accounts per month, or over 31 % of its total bills. Attached hereto as Schedule No. 2 is a calculation of the costs of processing delinquent accounts in order to justify the proposed late charge of \$3.00

Finally, I am also enclosing two original of the proposed revised tariff sheets to incorporate this late charge into the approved charges for this utility. Please return one of these originals with the commission's approval stamp once this application is approved.

I trust that the information provided will be all that is needed in order to approve this charge. We would appreciate your prompt attention to this matter so that we implement this charge in the very near future.
