Enclosed for filing is the original and fifteen (15) copies of Sprint-Florida, Incorporated's ("Sprint-Florida") Petition for Approval of Interconnection Agreement with KMC Telecom, Inc. ("KMC").

Filing of this Agreement was delayed while Sprint-Florida and KMC discussed the effects of the Opinions of the Eighth Circuit Court of Appeals on the terms of the Agreement. It is Sprint-Florida's position that certain portions of the Agreement require amendment to accommodate the rulings of the United States Eighth Circuit Court of Appeals. KMC has refused to renegotiate those portion of the Agreement affected by the Court's opinions.

Sprint-Florida is filing the Agreement for the sole purpose of complying with the Telecommunications Act of 1996. Sprint-Florida specifically does not waive its right to seek arbitration under the terms of the Agreement should any issues concerning the effects of opinions of the United States Eighth Circuit Court of Appeals on the provisions of the Agreement become a matter of contention between Sprint-Florida and KMC during term of the Agreement.


