Dear Ms. Bayo,

On August 20, 1996, the Commission granted to Digital Services Corporation ("DSC") Certificate No. 4708, authorizing it to provide alternative access vendor ("AAV") service within the State of Florida.1 On January 27, 1997, the Commission also granted to DSC Certificate No. 4793, authorizing it to provide alternative local exchange ("ALEC") service within the State.2

On November 13, 1997, the Commission granted to a DSC affiliate, Teligent, L.L.C. ("Teligent"), AAV and ALEC authority.3 In response to Question 1 of its AAV application, Teligent had represented to the Commission that, upon grant of authority to Teligent, DSC would cancel its AAV certificate. A similar representation was made in response to Question 2 of Teligent's ALEC application. Accordingly, DSC hereby respectfully requests that the Commission cancel its AAV and ALEC certificates, Certificate Nos. 4708 and 4793, respectively.


