RE: Docket No. 971186-SU - Application for approval of reuse project plan and increase in wastewater rates in Seminole County by Sanlando Utilities Corporation.

Dear Mr. Simmons:

This is to confirm the Commission's receipt of your letter dated December 10, 1997, along with the utility's revised Exhibits Nos. 4 and 5 to its original filing, and revised workpapers to support those revised exhibits.

Because your letter indicates that the utility wishes to amend its initial filing to include the above-referenced revised exhibits and workpapers, the Commission staff will review the amended filing and will advise you of the new official date of filing, which will be established pursuant to Rule 25-30.025, Florida Administrative Code. As we discussed by telephone, the new official date of filing will be the date on which the amended exhibits and workpapers were filed, provided they contain no deficiencies as determined by the Director of the Division of Water and Wastewater, or if it is determined that the revised schedules are deficient, to the date upon which those deficiencies are satisfied. As you know, the establishment of a new official date of filing will operate to begin anew the statutory five-month time period by which the Commission is required to enter its PAA vote to approve or disapprove the utility's reuse project plan pursuant to Section 367.0817(2), Florida Statutes.
