COLUMBIA COUNTY RESOLUTION NO. 97R-4J

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF COLUMBIA COUNTY, FLORIDA, REQUESTING THE FLORIDA PUBLIC SERVICE COMMISSION TO CREATE AN EXTENDED AREA SERVICE BETWEEN THE CALLING PREFIXES OF SOUTHERN COLUMBIA COUNTY (497 AND 454) AND THE GAINESVILLE/HIGH SPRINGS/ALACHUA COUNTY CALLING PREFIXES .

WHEREAS, residents of the Southern portion of Columbia County, Florida, in and near the town of Ft. White, Florida, are desirous of having the Florida Public Service Commission create an extended area service between the calling prefixes of Southern Columbia County (497 and 454) and the Gainesville/High Springs/Alachua County area calling prefixes; and

WHEREAS, the Board of County Commissioners of Columbia County, Florida, as the governing body of Columbia County, Florida, deems such extended area service to be in the best interest of the citizens and residents of the affected area of Southern Columbia County.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Columbia County, Florida, that;

- 1 The above recitals are incorporated as set forth in the body of this resolution
- 2 The Board of County Commissioners of Columbia County, Florida, hereby request the Florida Public Service Commissioner to create an extended area service between the calling prefixes of Southern Columbia County (497 and 454) and the Gainesville/High Springs/Alachua County calling prefixes.
- 3 This resolution shall be effective upon its adoption. Copies of this resolution shall be forwarded to the Florida Public Service Commission for its immediate attention and action upon this request.

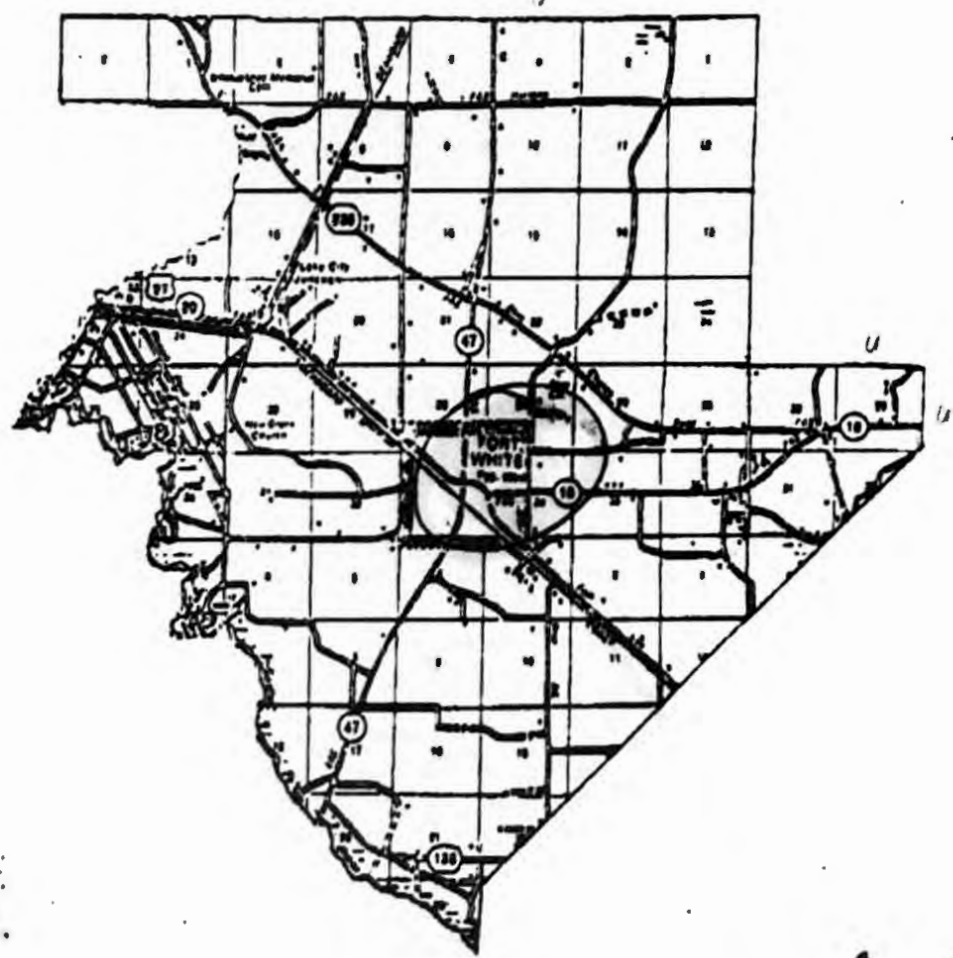
