A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF COLUMBIA COUNTY, FLORIDA, REQUESTING THE FLORIDA PUBLIC FLORIDA SERVICE COMMISSION TO CREATE AN EXTENDED AREA SERVICE BETWEEN THE CALLING PREFIXES OF SOUTHERN COLUMBIA COUNTY (497 AND 454) AND THE GAINESVILLE/HIGH SPRINGS/ALACHUA COUNTY CALLING PREFIXES.


