CASE BACKGROUND

On February 12, 1992, the Commission granted Interexchange Telecommunications Certificate No. 2942 to InterAmerican Telephone Co. (ITC). On April 28, 1997, the Division of Records and Reporting received mail sent to ITC marked, "Insufficient Address, Return To Sender." On May 9, 1997, Communications staff attempted unsuccessfully to reach ITC by calling the telephone number listed in the Master Commission Directory. The number had been disconnected. Directory assistance had no listing for the company.
