  - c. The amount of overhead (AFUDC, engineering, administrative, and other soft costs) which is included in the project's cost estimate.
  - d. All justifications which have been prepared for the project. If no justification is available, provide a brief description of the purpose of the project.
  - e. If the project changes the treatment capacity of a water or wastewater treatment plant, please provide both the new treatment capacity and the old treatment capacity.


