MOTION TO INTERVENE

CHARLOTTE COUNTY, FLORIDA, a political subdivision of the State of Florida, pursuant to Rule 25-22.039, Florida Administrative Code, hereby requests the Florida Public Service Commission to grant intervenor status to Charlotte County in the above-referenced proceeding, and in support thereof states that:

- 1. The proposed telephone exchange boundary between Sarasota County and Charlotte County bifurcates the community of Englewood, which is uniquely divided between both counties.
- 2. Both Charlotte and Sarasota County governments have worked diligently to promote and maintain a unified sense of community for Englewood area citizens.
- 3. Local government and private businesses are investing hundreds of thousands of dollars in the community of Englewood to redevelop and revitalize the downtown area for all the citizens of Englewood.
- 4. Imposing two different area codes in a community the size of Englewood would be unnecessarily cumbersome and confusing to the citizens of Englewood, and costly to the businesses within the bi-county area which depend on the unified Englewood identity for their livelihood.
- 5. Dividing the community into two different area codes would necessitate tendigit dialing for some residents to call local schools, medical facilities and commercial businesses.

THEREFORE, for the reasons above stated, Charlotte County, Florida, through its undersigned counsel, respectfully requests the Commission to grant full-party intervenor status to Charlotte County, Florida.
