**NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION**

Gulf Power Company ("Gulf", "Gulf Power" or the "Company") by and through its undersigned attorneys and pursuant to Rule 25-22.006, Florida Administrative Code, hereby gives notice that it intends to request confidential classification for the Company's responses to interrogatories numbered 1 and 17 of Commission Staff's 1<sup>st</sup> Set of Interrogatories to Gulf Power Company (Nos. 1-31) and either all or certain portions of the Company's responses to requests numbered 1, 2, 3, 10, 15 and 21 of Commission Staff's 1<sup>st</sup> Request for Production of Documents (Nos. 1-25). A copy of these responses is attached hereto as exhibit "A".

These responses contain proprietary confidential business information regarding trade secrets, contractual and bid information, and information relating to competitive interests the disclosure of which would cause irreparable harm to Gulf Power Company and the Southern Company. The information for which confidential classification is sought is intended to be and is treated by Gulf Power Company and the Southern Company as private. A formal request for confidential classification will be filed within the time period specified in Rule 25-22.006(3)(a),

Florida Administrative Code, if the Staff determines that the information will be retained by the Commission and not returned to the Companies within the specified time period.


