Re: Approval of an Amendment to the Resale Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and Comtec America, Inc. d/b/a Power Voice pursuant to Sections 251 and 252 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and Comtec America, Inc. d/b/a Power Voice are submitting to the Florida Public Service Commission their amendment to their negotiated agreement for the purchase of BellSouth's telecommunications services for the purpose of resale to end users by Comtec America, Inc. d/b/a Power Voice. The Commission approved the initial agreement between the companies in Order No. PSC-98-0989-FOF-TP issued July 20, 1998 in Docket 980481-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the amendment to the negotiated agreement between BellSouth and Comtec America, Inc. d/b/a Power Voice within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties aver that neither of these reasons exist as to the agreement they have negotiated and therefore, are very hopeful that the Commission shall approve their amendment.

## Amendment to Resale Agreement by and between BellSouth Telecommunications, Inc. and Comtec America, Inc., d/b/a Power Voice.

This Agreement refers to the Resale Agreement ("the Agreement") entered into by Comtec America, Inc., d/b/a Power Voice ("Comtec America") and BellSouth Telecommunications, Inc. ("BellSouth") on March 25, 1998. This Amendment ("Amendment") is made by and between Comtec America and BellSouth and shall be deemed effective on the date executed by Comtec America and BellSouth.

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Comtec America and BellSouth (individually, a "Party" and collectively, the "Parties") hereby covenant and agree as follows:

1. BellSouth and Comtec America are entering into this Agreement for the purpose of deleting the table of Operational Support System (OSS) Rates contained in Exhibit A of their existing Agreement in its entirety and replacing it with the new OSS rates as follows:

In addition to the OSS Charges, applicable discounted service order and related charges apply per the tariff.

2. The Parties agree that Comtec America will incur the mechanized rate for all LSRs, both mechanized and manual, if the percentage of mechanized LSRs to total LSRs exceeds the threshold percentages shown below:

| Year         | Ratio: Mechanized/Total LSRs |  |
|--------------|------------------------------|--|
| 19 <b>99</b> | 70%                          |  |
| 2000         | 80%                          |  |
| 2001         | 90%                          |  |

The threshold plan will be discontinued in 2002.

3. The Parties agree that the threshold plan described in Paragraph 2 above may be superceded by an LSR specific process that would apply the mechanized LSR rate to only those manual LSRs, which cannot be submitted over a mechanized system.

4. The Parties agree that all other provisions of the Agreement, dated March 25, 1998, shall remain in full force and effect.

5. The Parties further agree that either or both of the Parties is authorized to submit this Amendment to the Public Service Commission or other regulatory body having jurisdiction over the subject matter of this Amendment, for approval subject to Section 252(e) of the federal Telecommunications Act of 1996.
