NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING NEGOTIATED INTERCONNECTION AGREEMENT

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On September 9, 1998, DIECA Communications Inc. d/b/a Covad Communications Company (Covad) requested interconnection negotiations with GTE in three states, including GTE Florida Incorporated (GTEFL) pursuant to Section 252 of the Telecommunications Act of 1996 (the Act). The parties were unable to reach agreement on a number of issues. Therefore, Covad filed a Petition for Arbitration of the unresolved issues on February 16, 1999. This matter was set for hearing April 28, 1999.

Prior to the hearing, the parties notified us that they had reached an agreement. The hearing was, therefore, canceled. On April 30, 1999, pursuant to Section 252(e) of the Act, GTEFL filed a petition with us for approval of its negotiated interconnection, resale, and unbundling agreement with Covad.

According to Section 252(e), any interconnection agreement adopted by negotiation shall be submitted to the state commission for approval. A state commission may only reject an interconnection agreement if the agreement discriminates against a carrier not a party to the agreement, if the agreement is inconsistent with the public interest, convenience, and necessity, or if the agreement does not meet the requirements of Section 251.

Having reviewed this agreement, we find that it meets the standards set forth in Section 252(e). The agreement is, therefore, approved. We note that this agreement includes three appendices that have not been executed (signed), but have been included in the filing. These appendices are: Appendix G, SS7 Services; Appendix H, Pole Attachment Agreement; and Appendix I, Conduit Occupancy Agreement. When and if any of these appendices are executed, the parties shall amend their agreement and submit the amendment for our approval.

It is therefore

ORDERED by the Florida Public Service Commission that GTE Florida Incorporated's Petition for Approval of Interconnection, Resale and Unbundling Agreement with DIECA Communications, Inc. d/b/a Covad Communications Company is approved. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto. It is further

ORDERED that in the event this Order becomes final, this Docket shall be closed upon issuance of the consummating order.
