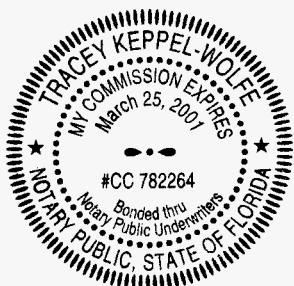



Notice is hereby given on June 4, 1999, pursuant to Section 367.045, Florida Statutes, of the application of Nocatee Utility Corporation to operate a water and wastewater utility to provide service to the following described territory in Duval County and St. Johns County, Florida.
