AERIAL COMMUNICATIONS, INC.'S MOTION FOR LEAVE TO FILE PREHEARING STATEMENT

Aerial Communications, Inc. ("Aerial"), by and through its undersigned counsel, hereby requests the Prehearing Officer to grant Aerial leave to file a prehearing statement in the above-captioned proceeding. In support of its Motion, Aerial states as follows:

- 1. Aerial is a wireless communications provider operating in the Tampa/Orlando/St. Petersberg MTA of the State of Florida and currently holds NXX codes in 813, 727, 941, 407, 352 and 904 area codes. On June 21, 1999, the undersigned counsel for Aerial was made aware that Aerial wishes to participate in this proceeding.
- 2. Prehearing Statements were due to be filed on June 9, 1999. The prehearing conference was held on June 16, 1999. At that time, three additional issues were raised and incorporated for resolution in this proceeding in the event the Commission does not approve the Stipulation and Voluntary Number Conservation Measures filed May 27,1999.
- 3. Aerial will not be filing testimony in this proceeding and does not object to Commission approval of the Stipulation. However, if the Stipulation is not approved, Aerial wishes to participate through the hearing process.
- 4. In light of the fact that Aerial has not filed testimony and will essentially be adopting positions previously taken by another wireless carrier already a party to this proceeding, Omnipoint Communications, Aerial respectfully submits that no party will be prejudiced by the late filing of nacing National Personal Expenses.
