### CASE BACKGROUND

STAFF DISCUSSION

ISSUE 1: Should Order PSC-99-0939-FOF-TI, dated May 11, 1999, canceling IXC Certificate No. 4020 be vacated and should the Commission issue a new order canceling IXC Certificate No. 3595 be issued?

RECOMMENDATION: Yes.

STAFF ANALYSIS: As explained in the Case Background of this recommendation, the wrong certificate was canceled. Therefore, staff is recommending that Order PSC-99-0939-FOF-TI, dated May 11, 1999, canceling IXC Certificate No. 4020 be vacated and the Commission issue a new order canceling IXC Certificate No. 3595 be issued.
