## ORDER GRANTING INTERVENTION

By Petition, ACI Corp. (ACI or the company), has requested permission to intervene in this docket, which was established to investigate the pricing of unbundled network elements (UNEs). ACI is an alternative local exchange carrier and an interexchange carrier certified by this Commission to provide services in the State of Florida. There has been no response filed in opposition to this request.

ACI alleges that "as a future provider of facilities-based high-speed data communications services throughout Florida," it will purchase UNEs from BellSouth and other incumbent local exchange carriers, and "any actions affecting the pricing of those UNEs will impact ACI's substantial interests."

Having reviewed the Petition, it appears that the company's substantial interests may be affected by this proceeding. Therefore, the Petition should be granted. Pursuant to Rule 25.039, Florida Administrative Code, however, the company takes the case as it finds it.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the Petition for Leave to Intervene filed by ACI Corp., be and the same is hereby granted. It is further

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
